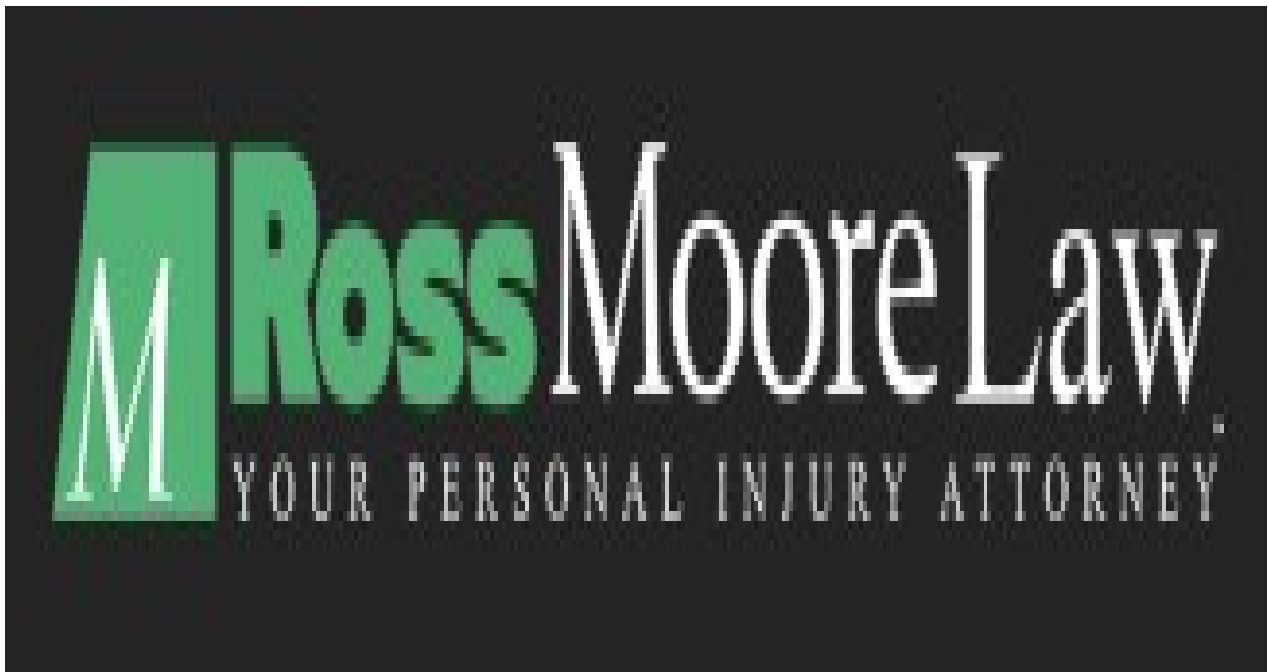




## **Ross Moore Law Addresses Pain and Suffering Calculations in Personal Injury Cases**
